Dear members of the European Court of Human Rights and the Committee Against Torture of the United Nations

We address you with the utmost respect as individuals who were subjected to torture during the late period of Franco's dictatorship and the Spanish Transition by members of the Spanish Security Forces, particularly the Politico-Social Brigade. These repressive units of the Franco's dictatorship targeted, detained, and tortured political dissidents, as well as, anyone the regime considered contrary to its promoted values and identity: members of the Roma community, people of diverse sexual and/or gender identities, national identities, individuals in situations of economic vulnerability, sex workers, among others.

It has now been 50 years since the death of the dictator Francisco Franco, and 50 years as well since we, the repressed individuals and victim groups, began demanding justice for the crimes against humanity we suffered firsthand. We have approached political leaders, organized protests, demanded access to police archives, participated in debates, conferences, and awareness campaigns, educated younger generations, filed claims, promoted legislative changes, brought cases before the courts, and contributed to or appeared in films and documentaries. Beyond occasional kind words, the response has always been the same: that the crimes committed by dictatorship's institutions had been amnestied and could not be investigated or prosecuted, and that it was best not to reopen the past. We have continued to fight, and some of us have even reached regional and international bodies like the ones you represent. Until now, these institutions have responded that our claims are too late, that they should have been filed earlier.

To this, we ask you: earlier when? In the 1980s, when systematic torture was still ongoing and the Franco's police forces and judiciary had not been purged? In the 1990s, when the so-called "pact of silence" was only beginning to break, and in front of the State's complete inaction, we were focusing our efforts on self-organizing to recover the memory of atrocities committed during the war and the early years of the dictatorship? In the 2000s, when, while working for a Historical Memory Law that ended up being little more than symbolic, and as we began to approach the courts, the first judge who attempted to investigate the dictatorship's crimes was charged and prosecuted for prevarication? Let us recall that it is precisely that 2012 Supreme Court ruling that entrenched impunity and laid the foundation that prevents justice from being served today. In the 2010s and beyond, when we collectively, as a group of victims, turned to Argentina so that crimes against humanity could be investigated there under the principle of universal jurisdiction? An investigation which, though symbolically significant, has not resulted in any effective judicial proceedings due to obstruction by Spanish authorities.

After all this, between 2015 and 2020—was that also too late? When over 100 victims filed complaints of crimes against humanity through torture across Spain, only to have them dismissed, perpetuating impunity?

It has only been with the adoption of the national Democratic Memory Law in 2022 that we finally have a legislative framework that, in theory, should respond to our longstanding demands for justice. This is why those of us now formally submitting this petition to your institution initiated criminal proceedings in Spain, believing that justice and reparation were finally possible. But the courts' response has been the same as always: the door remains closed due to a misinterpretation of the principle of legality and statute of limitations, and the 1977 Amnesty Law is cited to prevent investigations into Francoist crimes—even when these constitute crimes against humanity.

What else must happen? Many of those who suffered these crimes are no longer with us; they died without ever being heard by a judge, without their perpetrators being held accountable. We are still alive and still here, asking regional and international bodies to prevent Spain, through its judicial system, from continuing to mock the obligations it assumed when it ratified the European Convention on Human Rights and the Convention against Torture. We ask you to prevent Spanish courts from continuing, in 2025, to defy the fundamental, non-expiring values of dignity and justice.

With all due respect, but also with full conviction, we ask you to put an end to this impunity, because it is never too late for justice—but it must happen now, while we are still alive, while the perpetrators can still be held accountable for the horrific (and not subject to statutory limitations) acts they committed.
